Mayor Flowers inquired if request for proposals were obtained for these consultants.

City Manager Dadian replied that four companies were notified to submit proposals. She said that three companies responded to request. She presented information regarding what each company had to offer and what project they would service best.

Council Member Nelson stated that some of the councilmembers need to abstain from this item because of proximity of historical district.

Council Member Nelson and Mayor Pro Tem Lima abstained from award of bid for Construction Controls Group, Inc to provide project management consultant services for the Artesia Historical District.
