I the undersigned understands that if my insurance policy does not meet the aforementioned insurance coverage, then I am not qualified to drive team participants (players) to any location. I further understand that the cost and expense to maintain the policy of insurance in full force is my sole responsibility.

I the undersigned understand that "out-of-area" tournaments and/or games that require transportation by air plane, auto or other means; and "over-night-stay" accommodations should be presented to Recreation Staff 3-months prior to the scheduled event for Commission recommendation to the City Council for consideration.
