

**CITY OF ARTESIA VOLUNTEER PROGRAM
LIABILITY WAIVER AND
RELEASE AGREEMENT FORM**

By signing this volunteer waiver, I acknowledge and agree to the following:

1. I and/or my minor child am/is volunteering my services for the City of Artesia on a voluntary basis without anticipation of payment of any kind.
2. I acknowledge that the City of Artesia has extended its workers' compensation coverage to authorized volunteers. I agree to accept that coverage on the appropriate form.
3. I release, waive and discharge, on behalf of myself and/or my minor child, not to sue the City of Artesia ("City"), their officials, agents, volunteers, and employees from all liability to me or to my minor child, for any loss or damage or death, and any claim or demands on account of personal or property injury, whether caused by negligence or otherwise, while I, or my minor child, participate in the City of Artesia's Volunteer program.
4. I further agree to defend, indemnify, and hold harmless the City and its officers, employees and agents, from and against any and all claims, suits, actions, liability judgment and expenses that may arise by reason for services that I, or my minor child, provide as a volunteer or that are connected in any way therewith. I will pay all costs incident to any claim, including without limitation, attorney's fees.
5. I grant permission for the City to use my, or my minor child's image, filmed or photographed during volunteer activities, to promote its services and programs. I understand that I or my child will not be compensated for the use of those promotional materials.
6. In case of injury while volunteering, I give permission for City personnel to seek any medical treatment should it become necessary.

I have read and voluntarily sign this release, waiver of liability, and indemnity agreement, and further agree that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.
